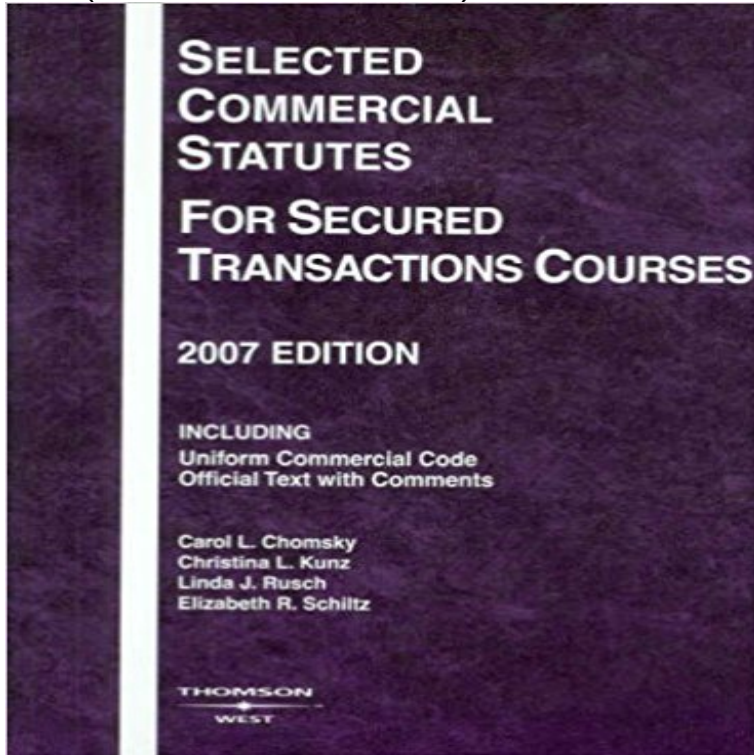


Selected Commercial Statutes for Secured Transactions Courses, 2007 ed. (Academic Statutes)



Selected Commercial Statutes supplements casebooks and other teaching materials in courses focusing on secured transactions. This statutory supplement includes the official text of the Uniform Commercial Code (UCC) prepared under the joint sponsorship of the American Law Institute and the National Conference of Commissioners on Uniform State Laws. It also provides the full official text and comments to the UCC as revised following the 2004 Annual Meeting, as well as pre-revision versions of Articles 1, 2, 2A, and 7. Also included are: 1) Uniform Fraudulent Transfer Act; 2) Uniform Certificate of Title Act; 3) Food Security Act of 1985; 4) Consumer Credit Protection Acts (selected sections); 5) Federal Trade Commission Credit Practices Rules; 6) Federal Tax Lien Statute; and 7) Bankruptcy Code (including BAPCPA).
