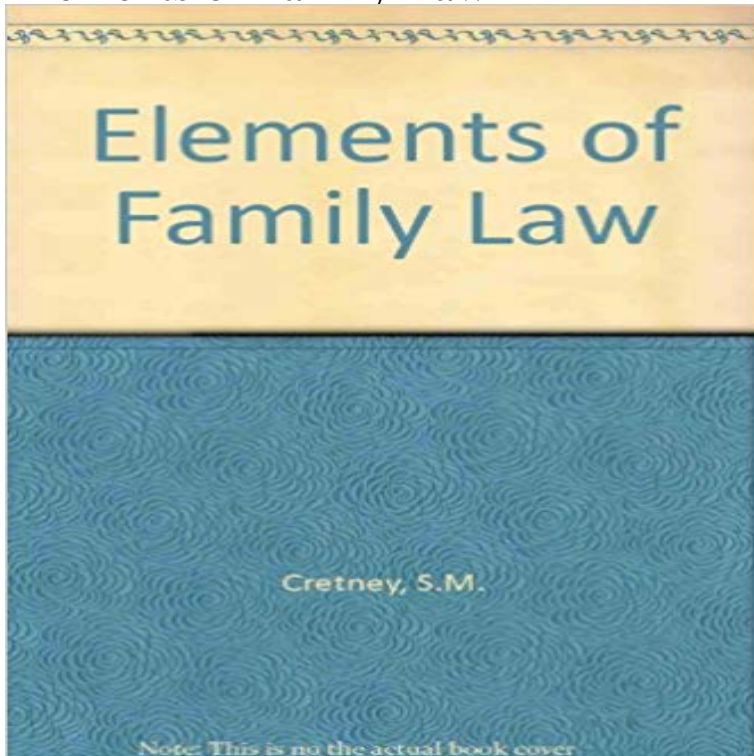


## Elements of Family Law
