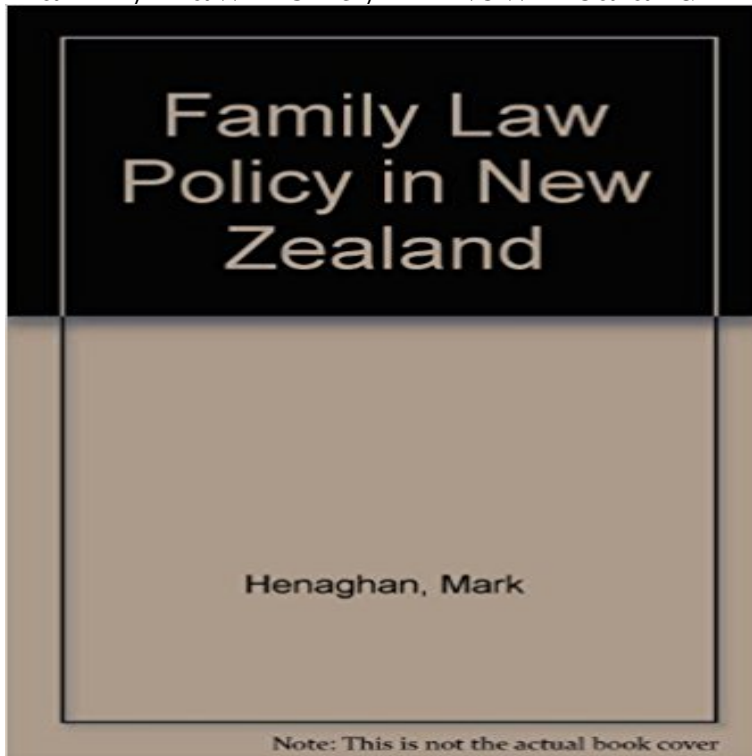


Family Law Policy in New Zealand
