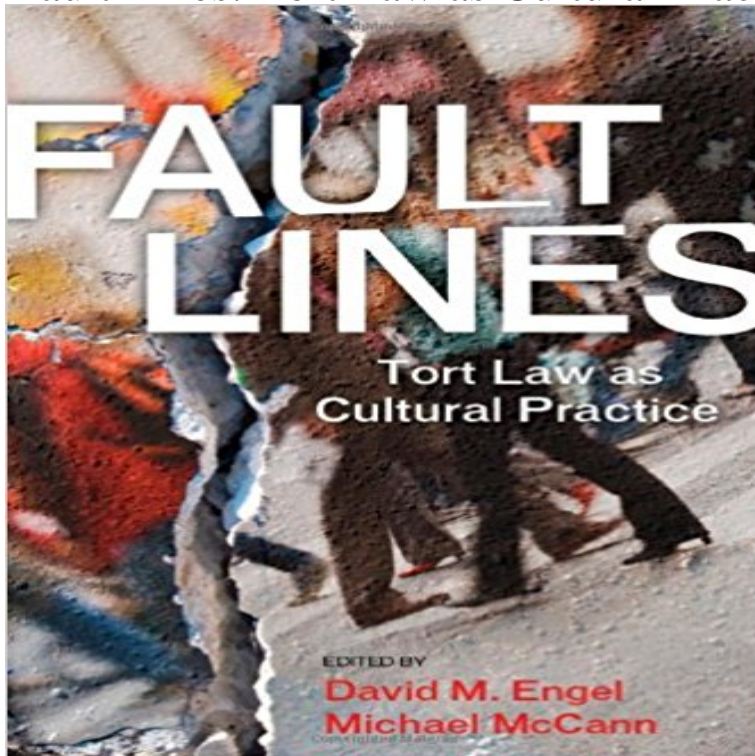


Fault Lines: Tort Law as Cultural Practice (The Cultural Lives of Law)
