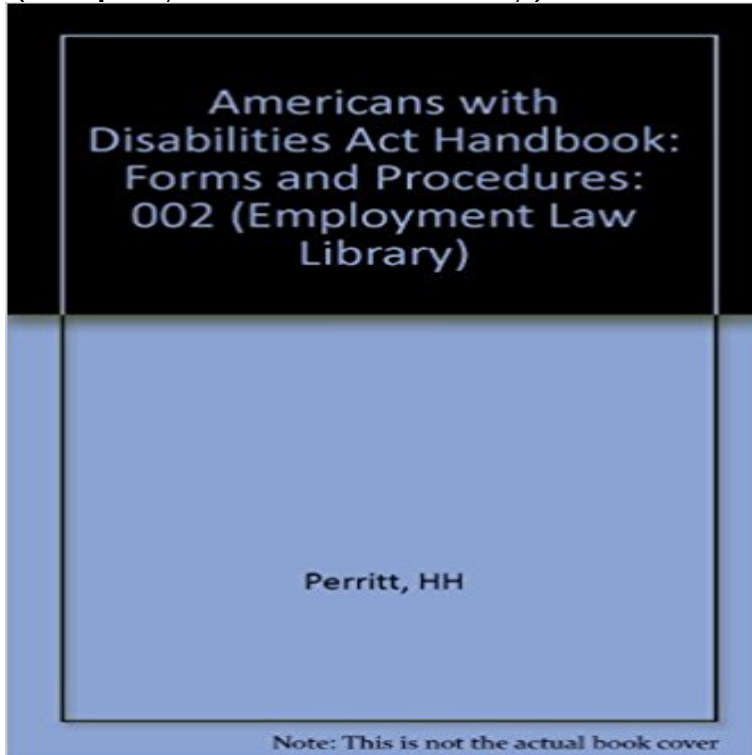


Americans With Disabilities Act Handbook Forms and Procedures (Employment Law Library)
