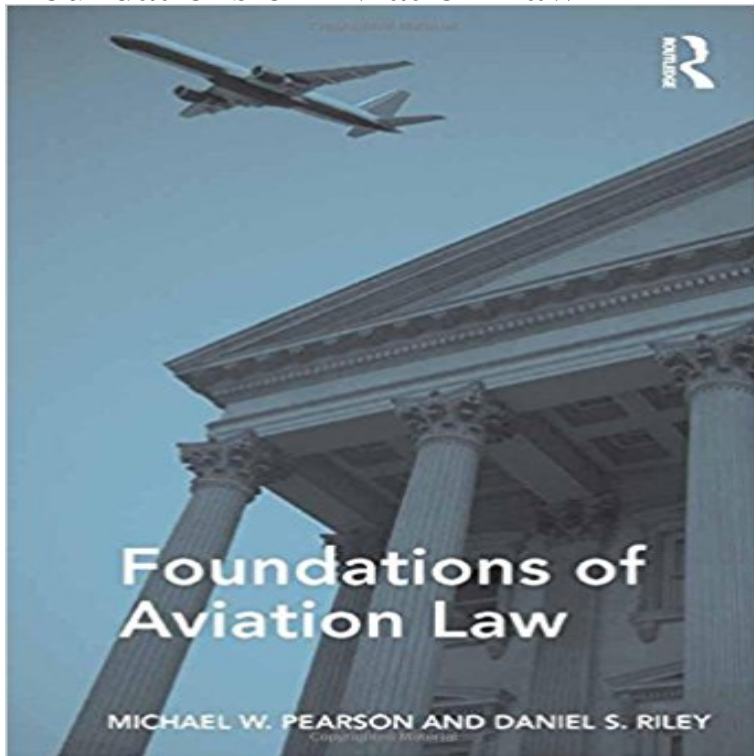


# Foundations of Aviation Law
