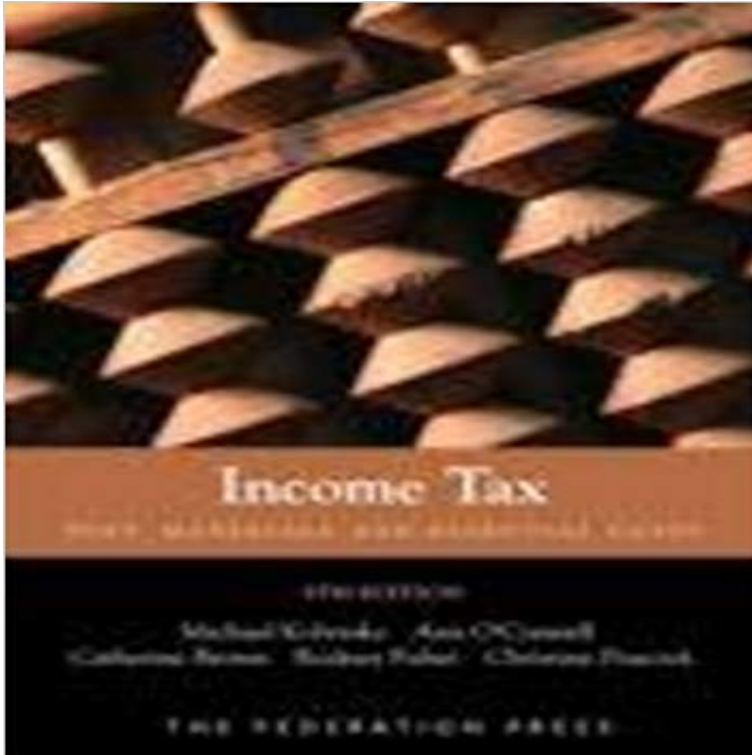


# Income Tax
