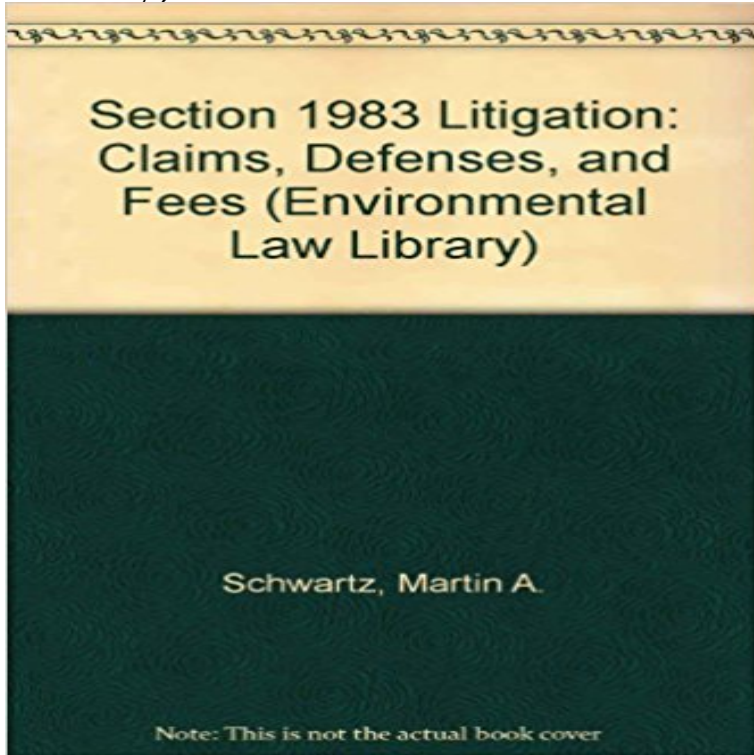


## Section 1983 Litigation: Claims, Defenses, and Fees (Environmental Law Library)
