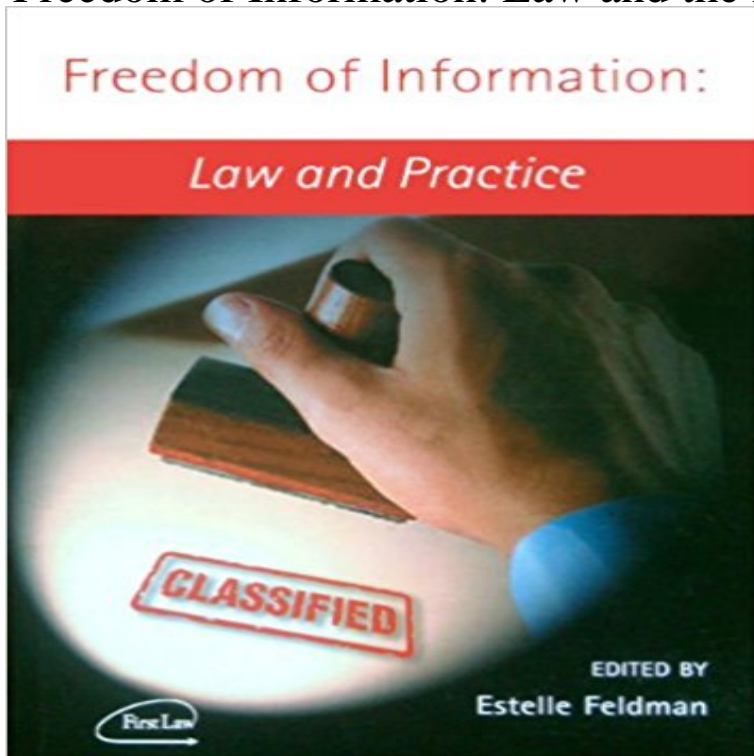


## Freedom of Information: Law and the Practice
