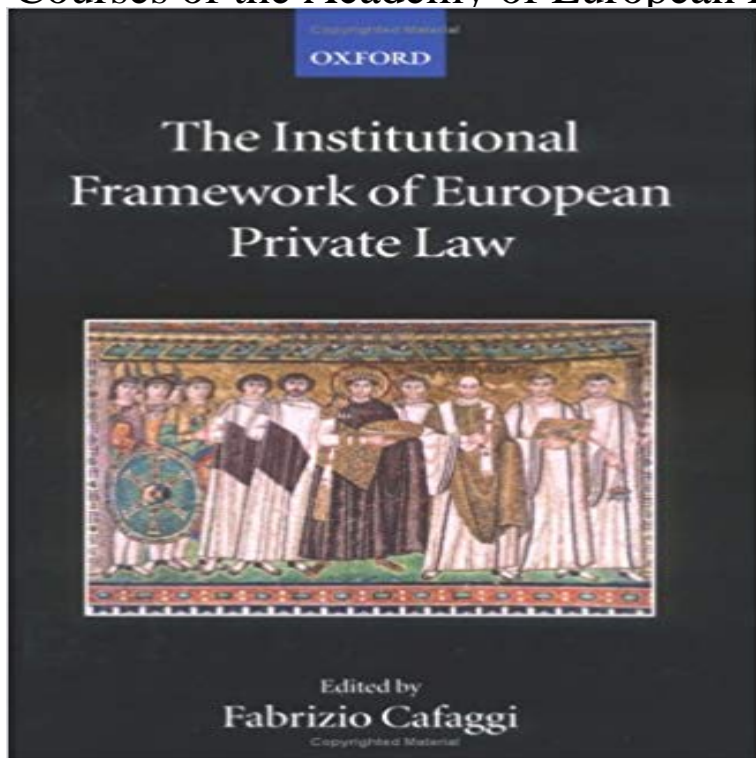


The Institutional Framework of European Private Law (Collected Courses of the Academy of European Law)
