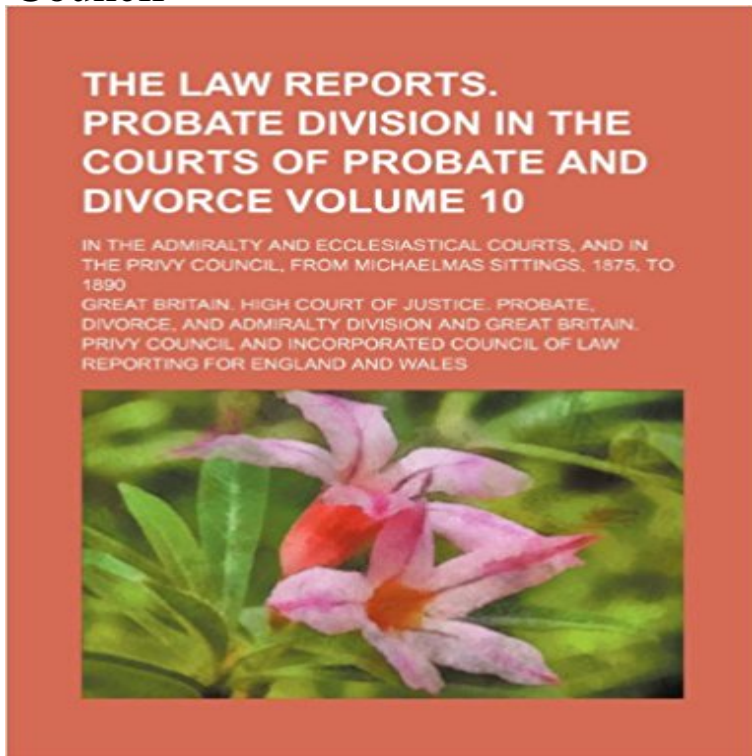

Not illustrated. 1885 Excerpt: ... 18;44fc45 Fic. c. 68, s. 9, An appeal from a decision of a judge of the Probate Division granting or refusing a new trial in the Divorce Court must be made within fourteen days in accordance with the Divorce Court Act, 1860 (23 & 24 Vict. c. 144), s. 2. In this case Eleanor E. Ahier presented a petition against her husband, Philippe Ahier, for dissolution of the marriage on the ground of cruelty and adultery. The action was tried on the 13th of February, 1885, by Butt, J., without a jury, and the respondent not appearing, a decree nisi was made for dissolution of the marriage. The respondent, on the 3rd of March, applied to Butt, J., for a new trial, but his Lordship refused the application. The respondent gave notice of appeal from this decision within twenty-one days from the date of the refusal of the application but after fourteen days had expired. C. H. Turner, for the appellant. InderwieJc, Q.O., and Bay ford, for Mrs. Ahier, took the preliminary objection that the appeal was brought too late. An appeal from the granting or refusal of a new trial in the Divorce Court must be brought within fourteen days. At the time when the Judicature Acts were passed the only right of appeal from the granting or refusal of an application for a new trial in the Divorce Court was under 23 & 24 Vict. c. 144, s. 2, which enacted that in addition to the cases in which an appeal to the full Court now lies from the decisions of the Judge Ordinary, either party dissatisfied with the decision of such judge sitting alone granting or refusing an application for a new trial which by virtue of the Act he is empowered to hear and determine, may within fourteen days after the pronouncing thereof appeal to the full Court, whose

decision shall be final. T...
