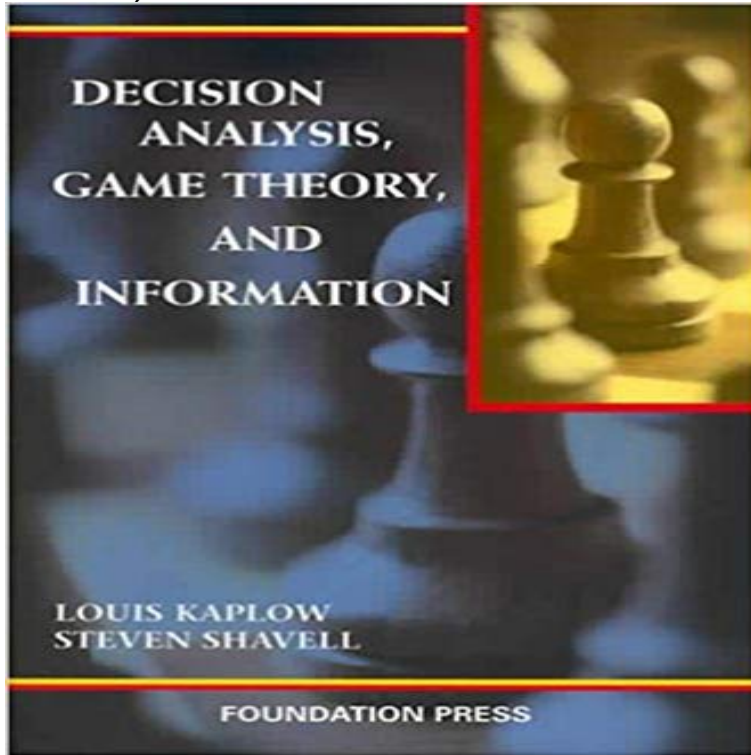


Decision Analysis, Game Theory, and Information (University Casebook Series)
