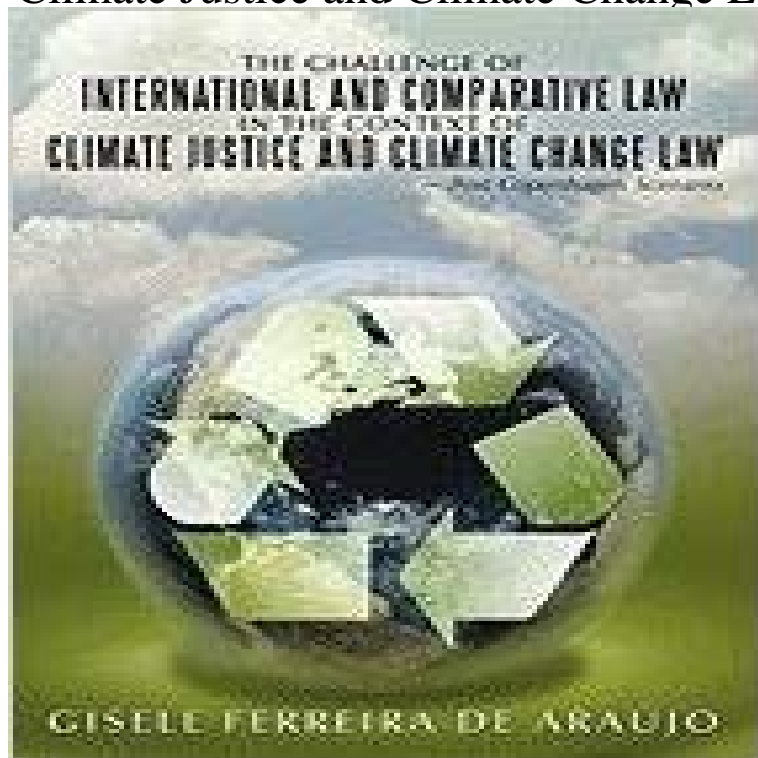


# The Challenge of International and Comparative Law in the Context of Climate Justice and Climate Change Law - Post Copenhagen Scenario
