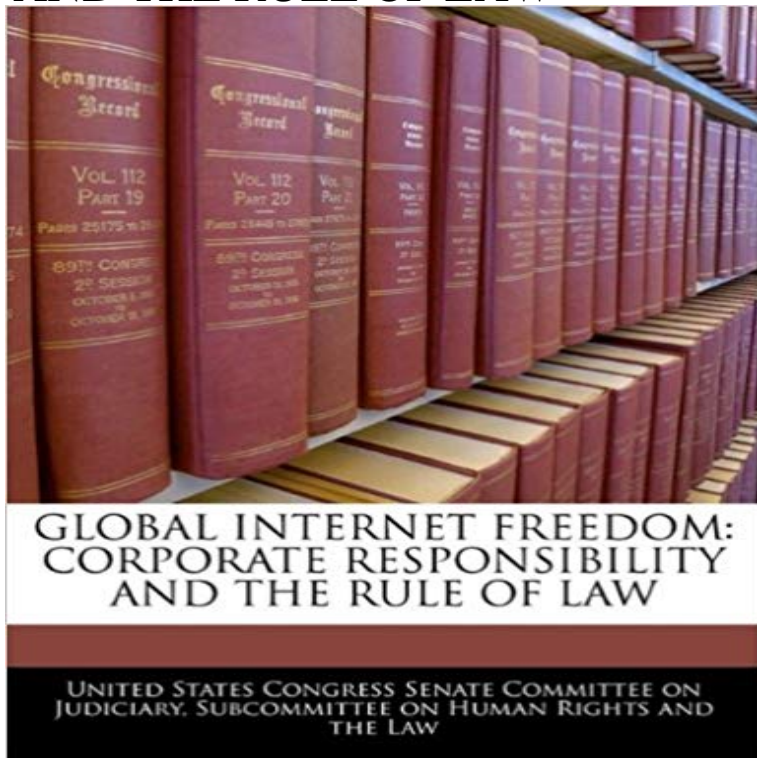


# GLOBAL INTERNET FREEDOM: CORPORATE RESPONSIBILITY AND THE RULE OF LAW
