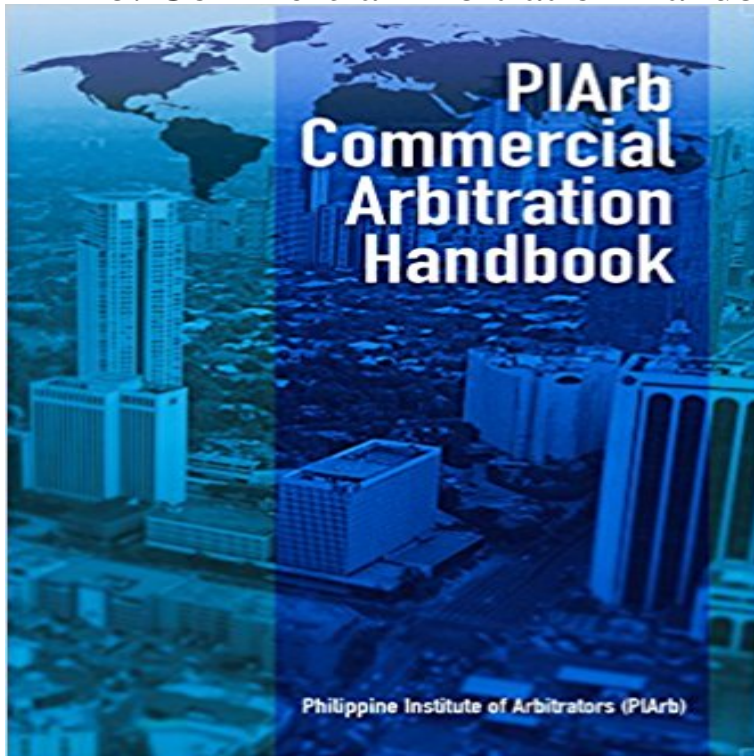


PIArb: Commercial Arbitration Handbook
