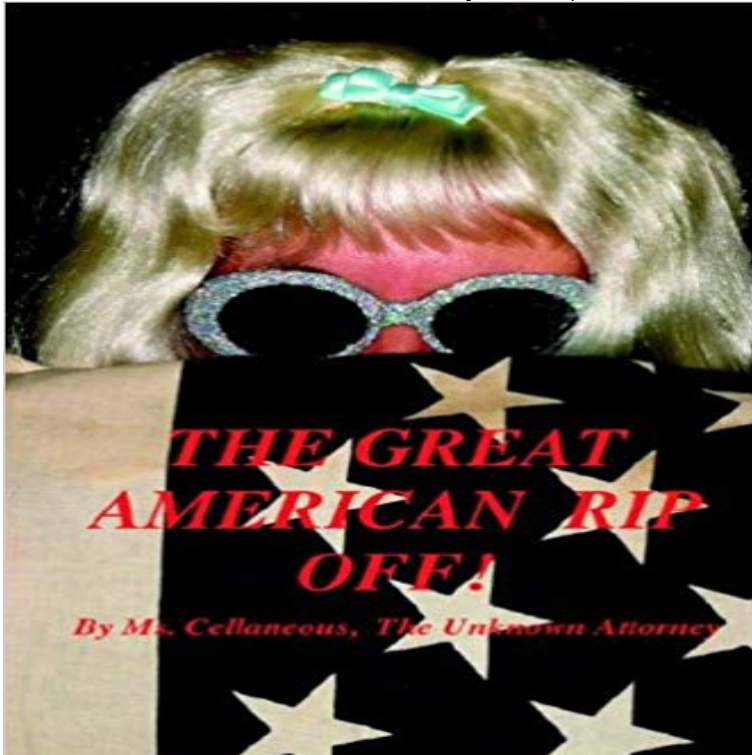


The Great American Rip Off, Part I
