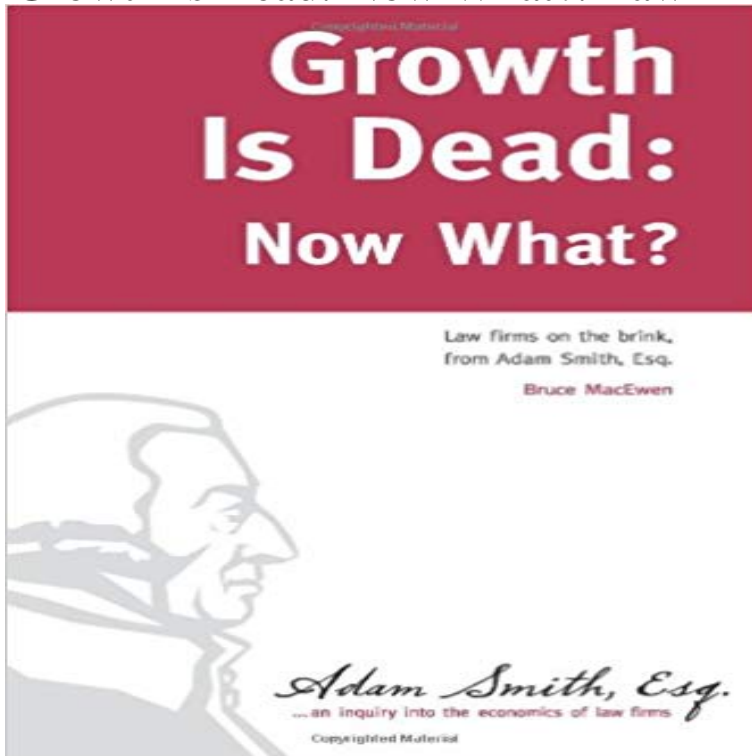


## Growth Is Dead: Now What?: Law firms on the brink
