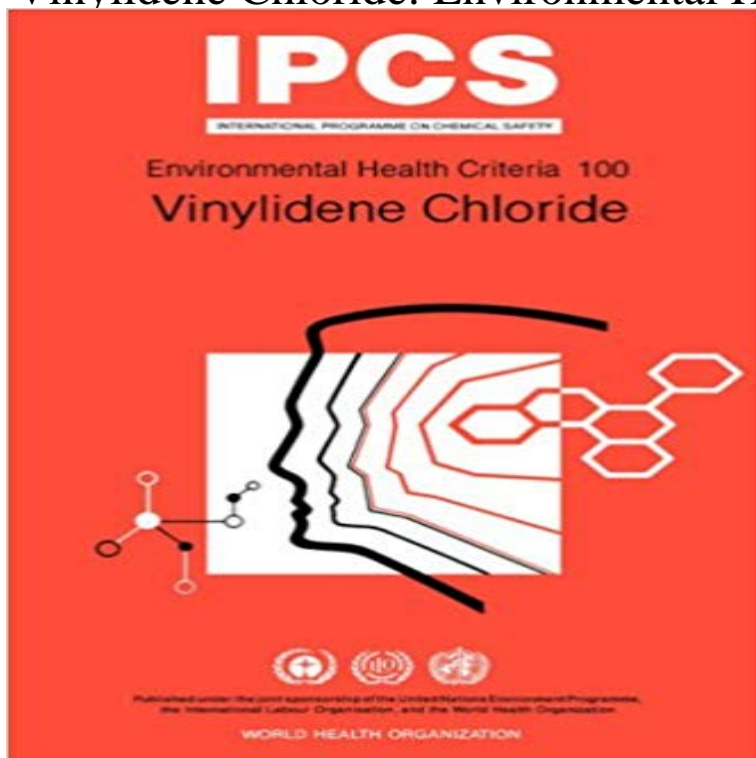


Vinylidene Chloride: Environmental Health Criteria Series No. 100

Vinylidene chloride/vinyl chloride copolymers are used for the packaging of foods, as metal coatings in storage tanks, building structures, and tapes, and as moulded filters, valves, and pipe fittings. Food packaging applications include both commercial packaging films and household wraps.
