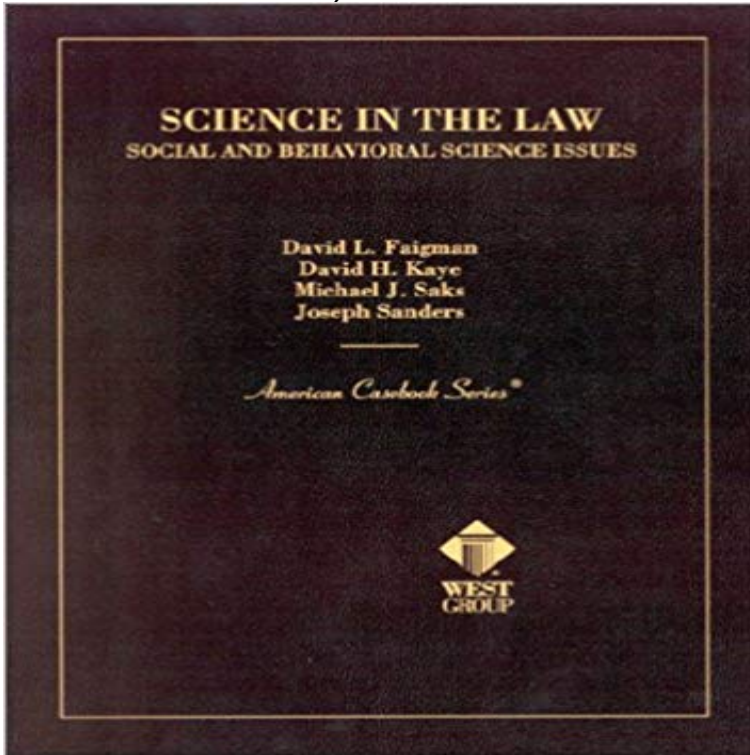


Science in the Law: Social and Behavioral Science Issues (American Casebook Series)
