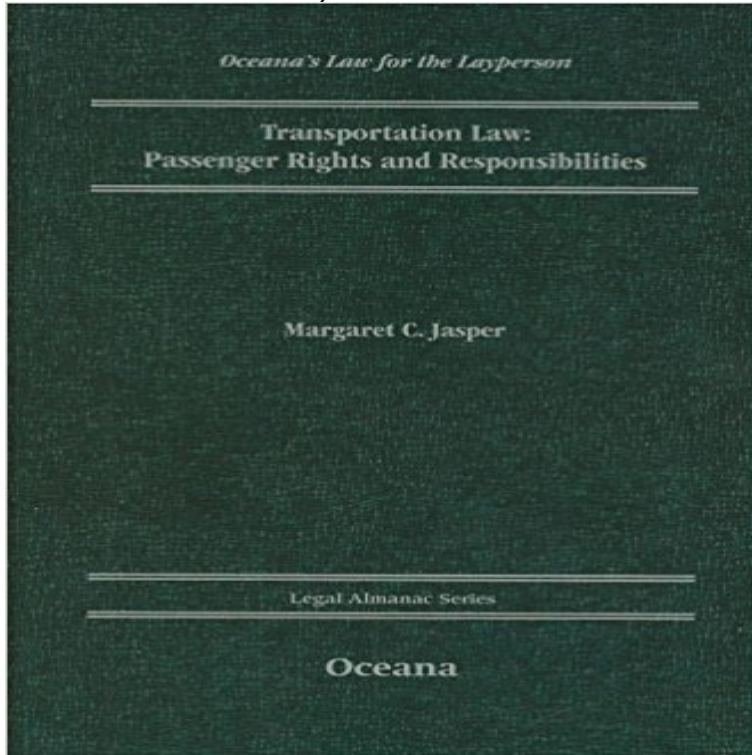


Transportation Law: Passenger Rights and Responsibilities (Legal Almanac Series)
