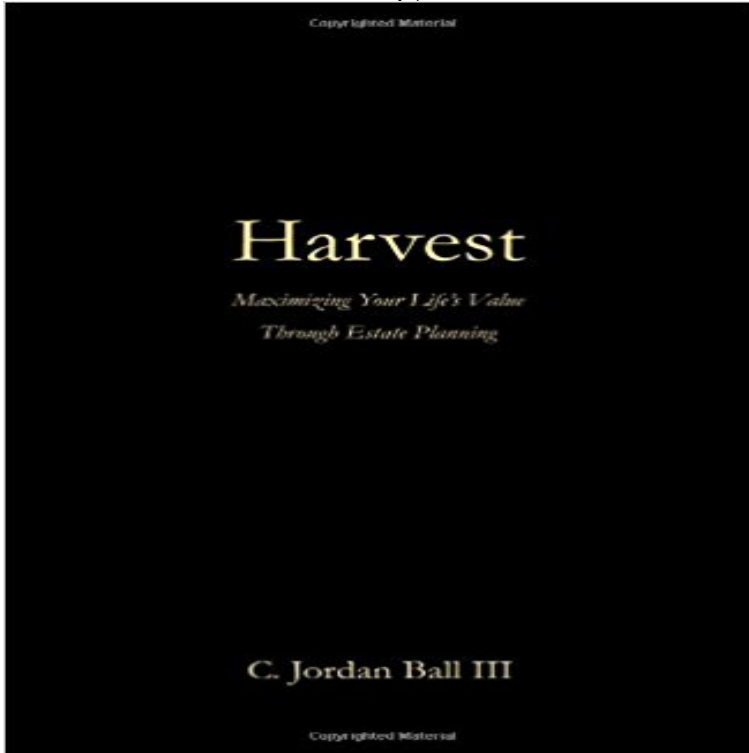


Harvest: Maximizing Your Life's Value Through Estate Planning
