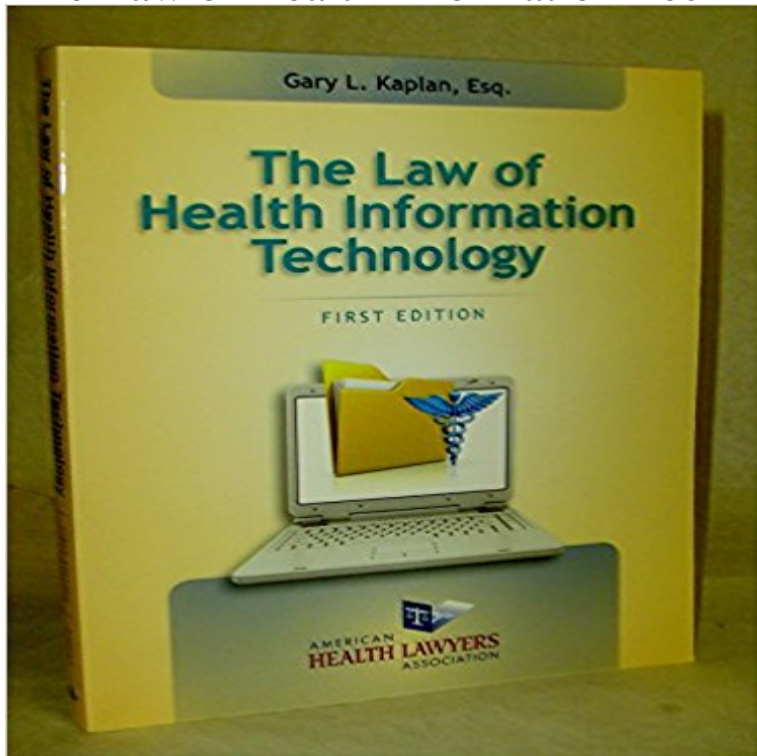


The Law of Health Information Technology
