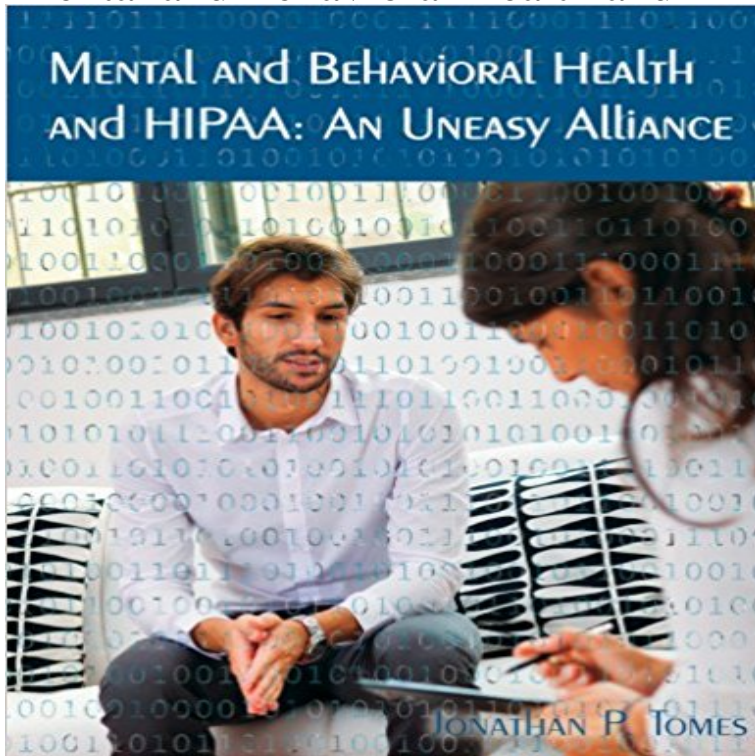


## Mental and Behavioral Health and HIPAA: An Uneasy Alliance



In some ways, HIPAA compliance is easier for mental and behavioral health practitioners because they have always had a culture of confidentiality unlike others in the health care business. But because of the extremely sensitive nature of such information, which may result in a mental health client or a substance abuse client losing his job or suffering other harm because his employer found out that he had bipolar disorder or was addicted to cocaine, some HIPAA issues are more complicated for such providers than for other practitioners, such as dentists, family practice doctors, physical therapists, and the like. This book discusses both the HIPAA security and privacy issues common to all practitioners and those that differ because of the unique nature of mental and behavioral health, such as these: Which applies, HIPAA or a state law requiring something that HIPAA does not? Does HIPAA allow group therapy? Does HIPAA's authorized disclosure to family members that are involved in a patient/client's care work for your clients? Does HIPAA's client right to access and copy his chart permit the clinician to withhold data that would make it more difficult to treat the client (the so-called therapeutic exception)? This book covers these topics and more in terms that at least one reviewer said were clearly and accurately presented. Another reviewer praised the book's examples and scenarios that are specific to the field.
