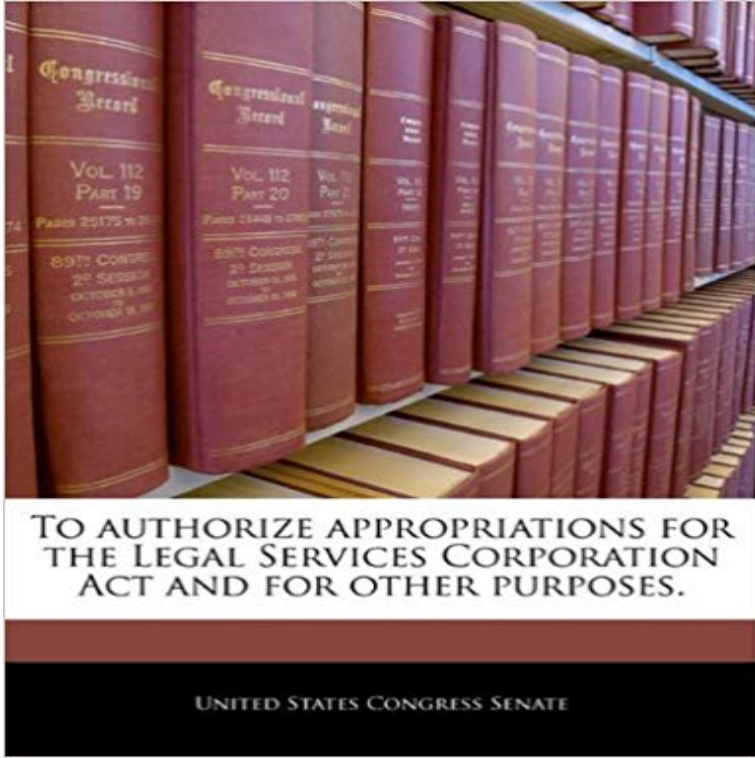


To authorize appropriations for the Legal Services Corporation Act and for other purposes.
