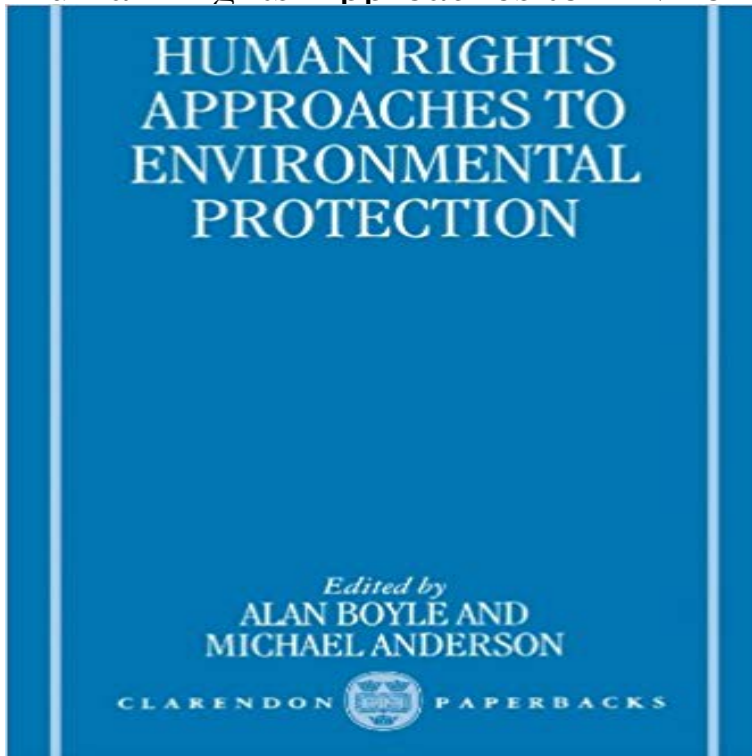


Human Rights Approaches to Environmental Protection
