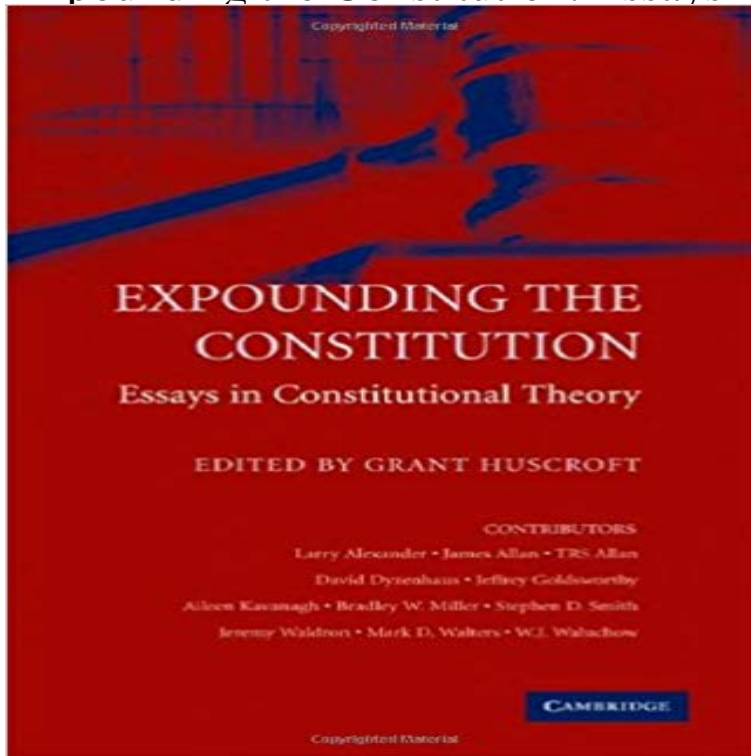


# Expounding the Constitution: Essays in Constitutional Theory
