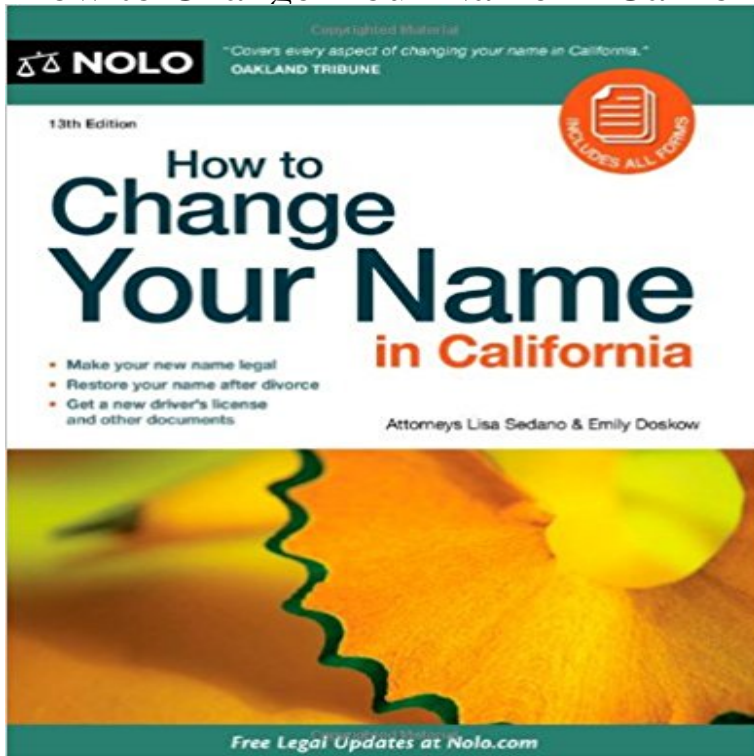


## How to Change Your Name in California
