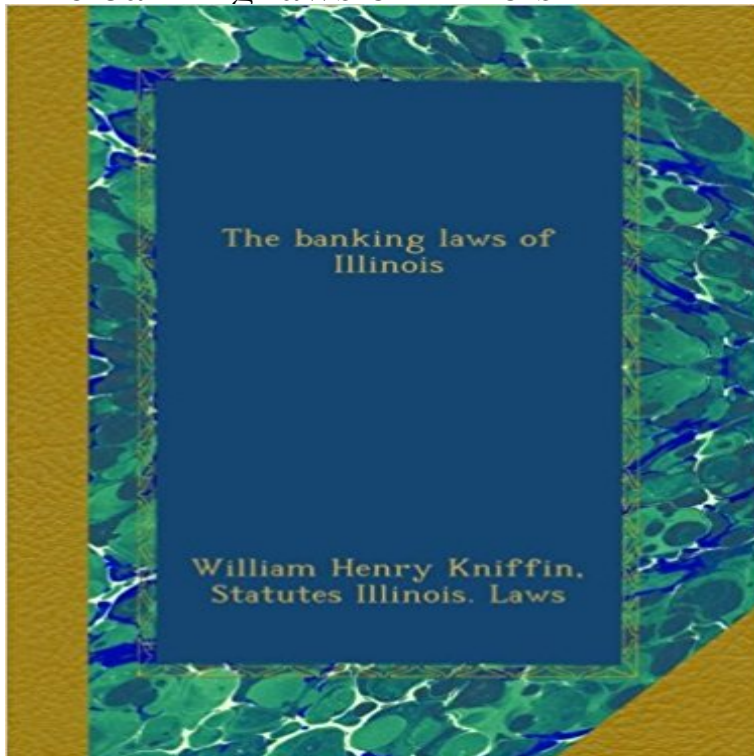


The banking laws of Illinois
