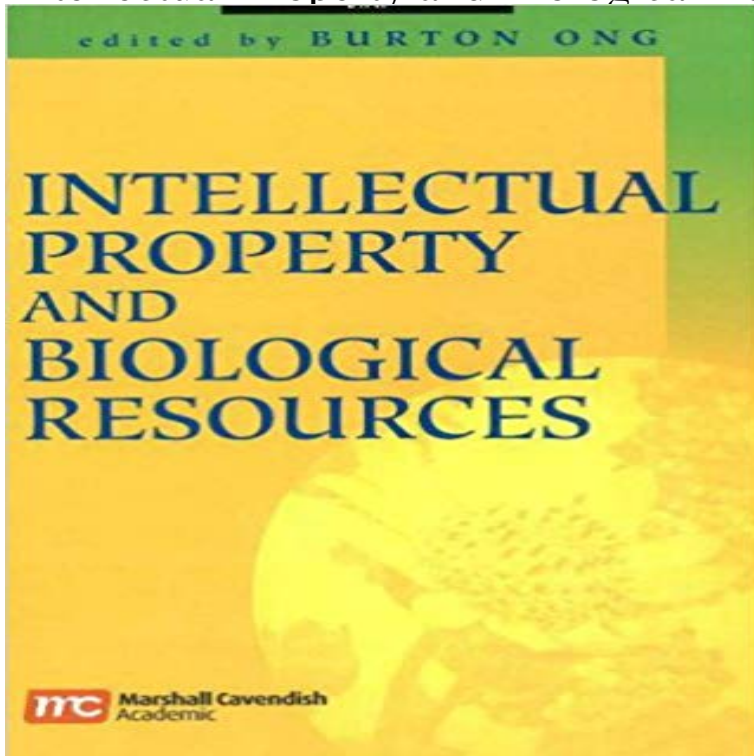


Intellectual Property and Biological Resources

These leading scholars were invited to present papers at a conference in Singapore, held in December 2003, which was organized by the Asia-Pacific Centre for Environmental Law (of the Faculty of Law at the National University of Singapore), the Singapore Academy of Law, the Intellectual Property Office of Singapore and the IP Academy. In recognition of the global character of the controversies that have emerged in this area of law, and the broad range of attendant issues that have arisen, a conscious effort was made to select scholars with expertise in different legal sub-specialties, including patent law, international environmental law, indigenous rights, traditional knowledge, and from countries in different geographical regions.
