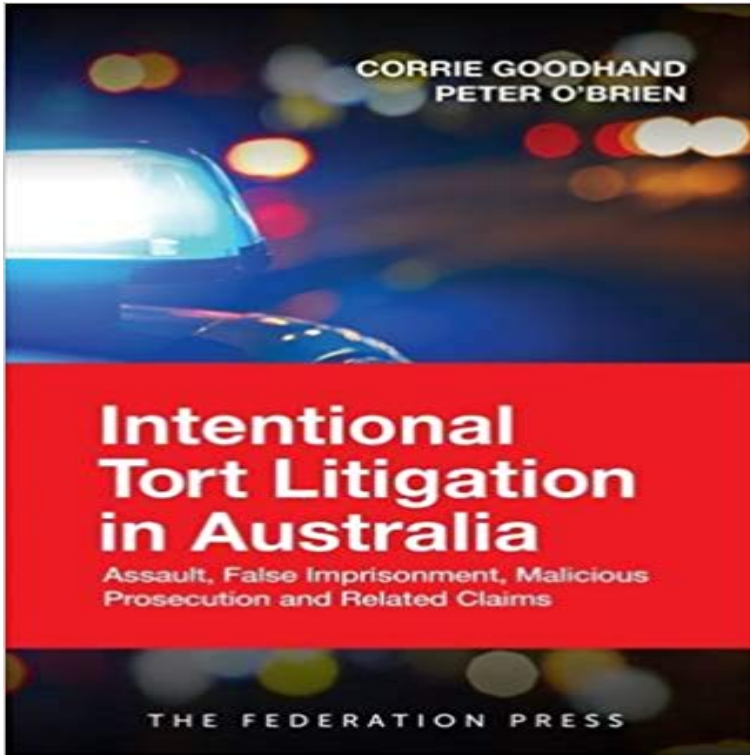


# Intentional Tort Litigation in Australia: Assault, False Imprisonment, Malicious Prosecution and Related Claims
