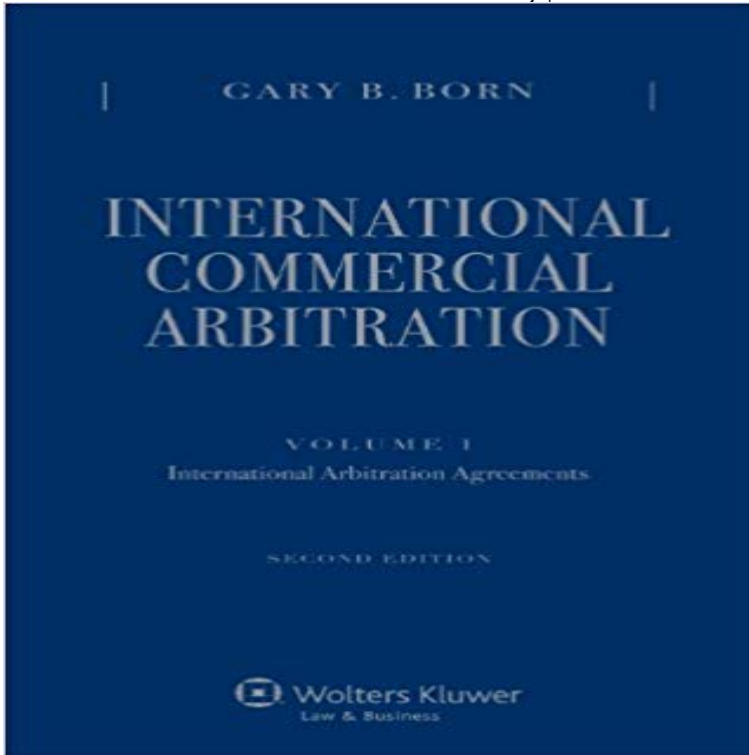


# International Commercial Arbitration, Second Edition, Volume I: International Arbitration Agreements
