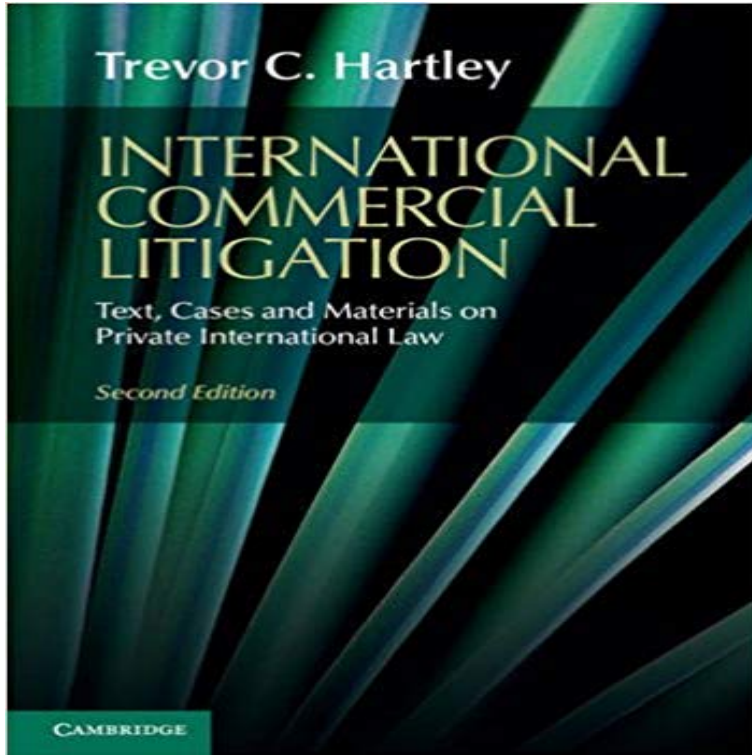


International Commercial Litigation: Text, Cases and Materials on Private International Law
