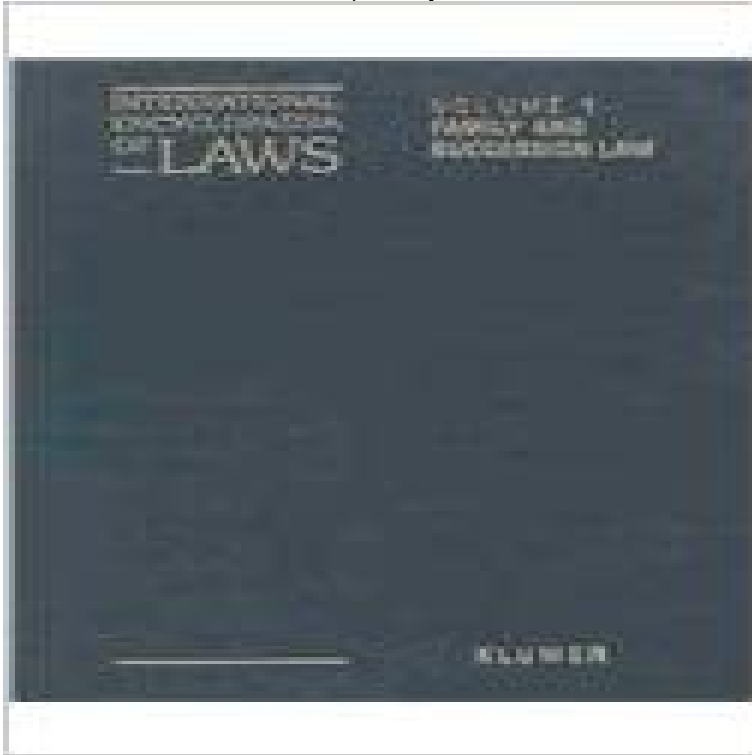


## International Encyclopaedia of Laws: Family & Succession
