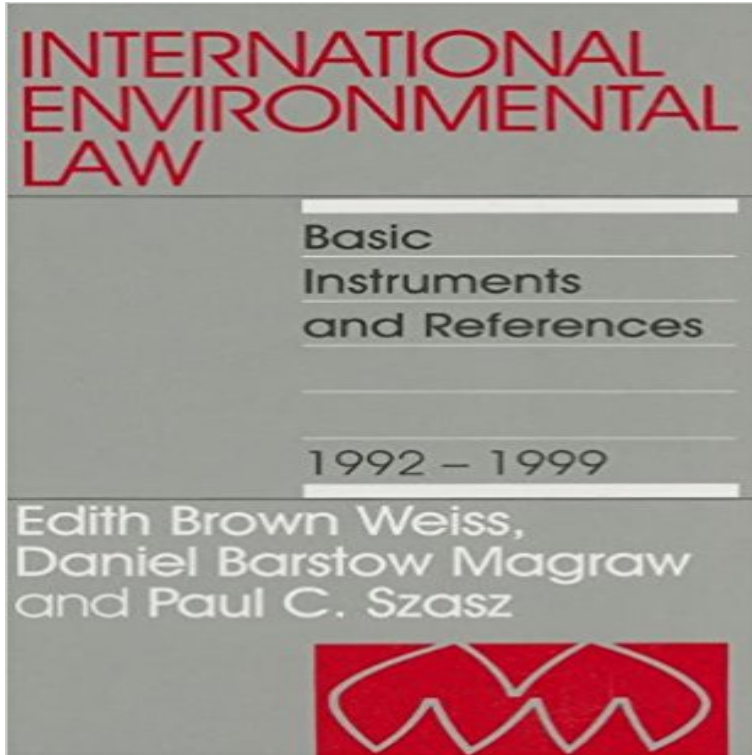


# International Environmental Law: Basic Instruments and References, 1992-1999
