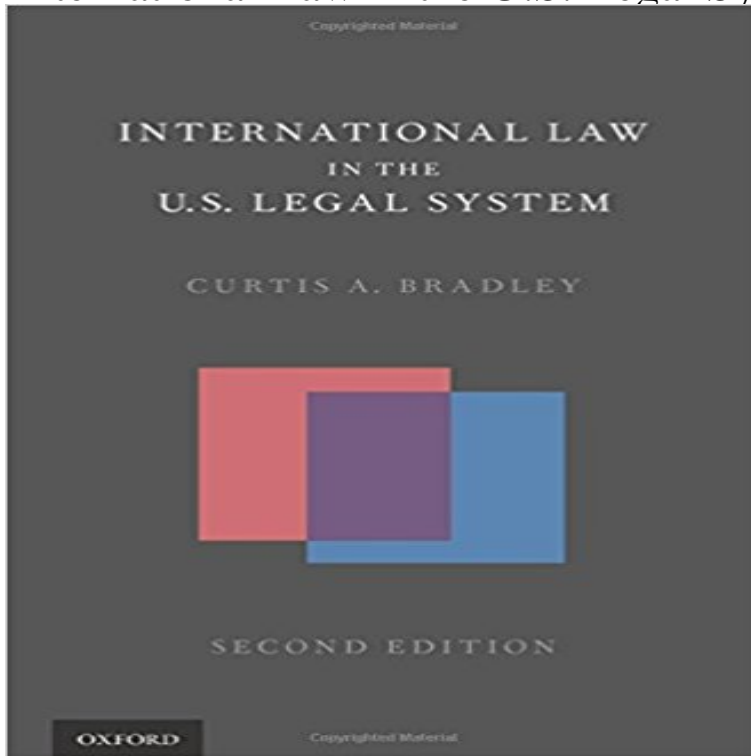


# International Law in the U.S. Legal System
