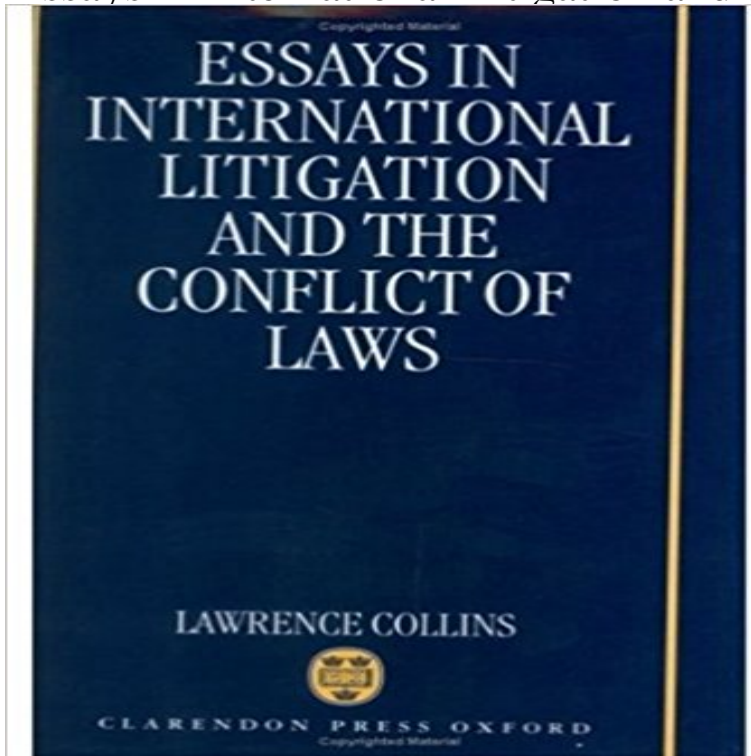


## Essays in International Litigation and the Conflict of Laws
