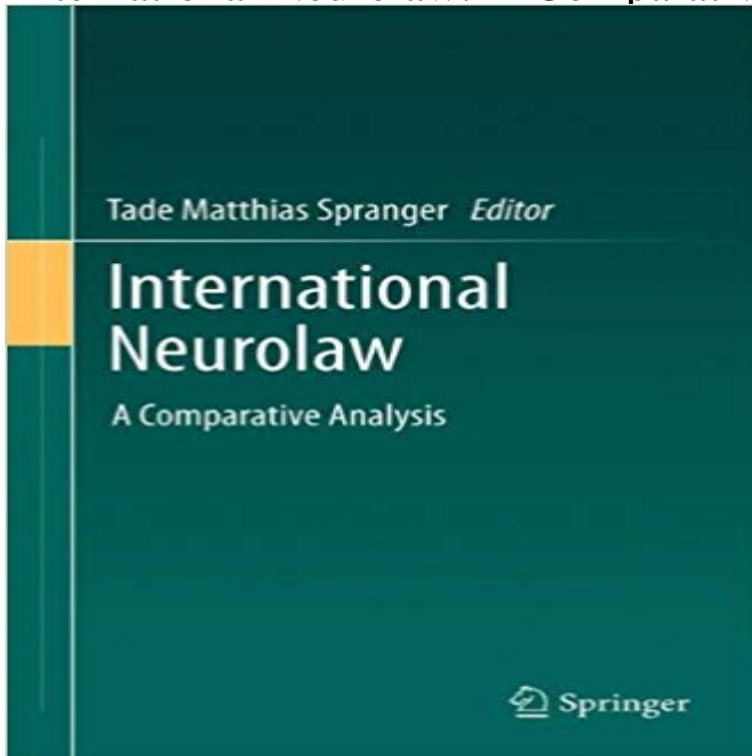


International Neurolaw: A Comparative Analysis
