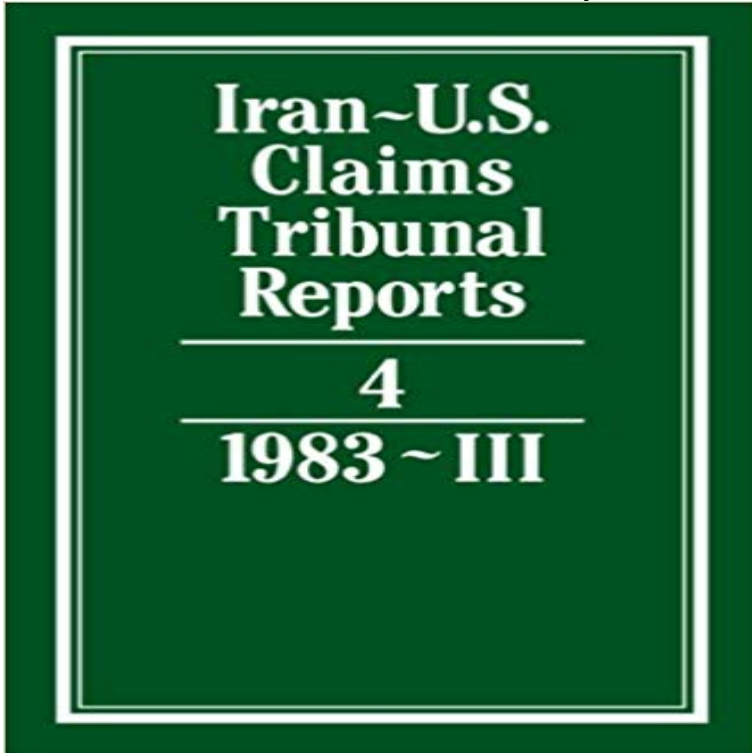


## Iran-U.S. Claims Tribunal Reports: Volume 4
