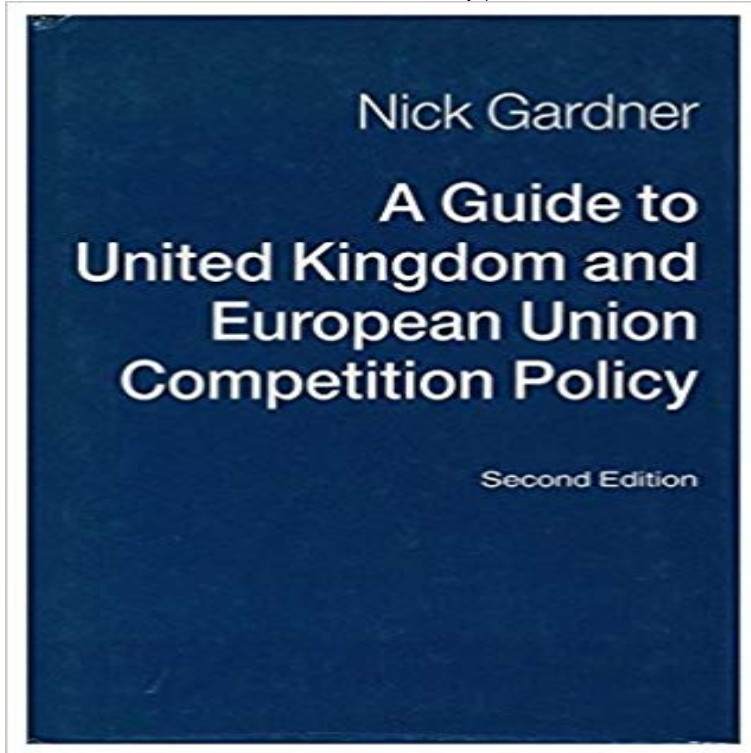


A Guide to United Kingdom and European Union Competition Policy
