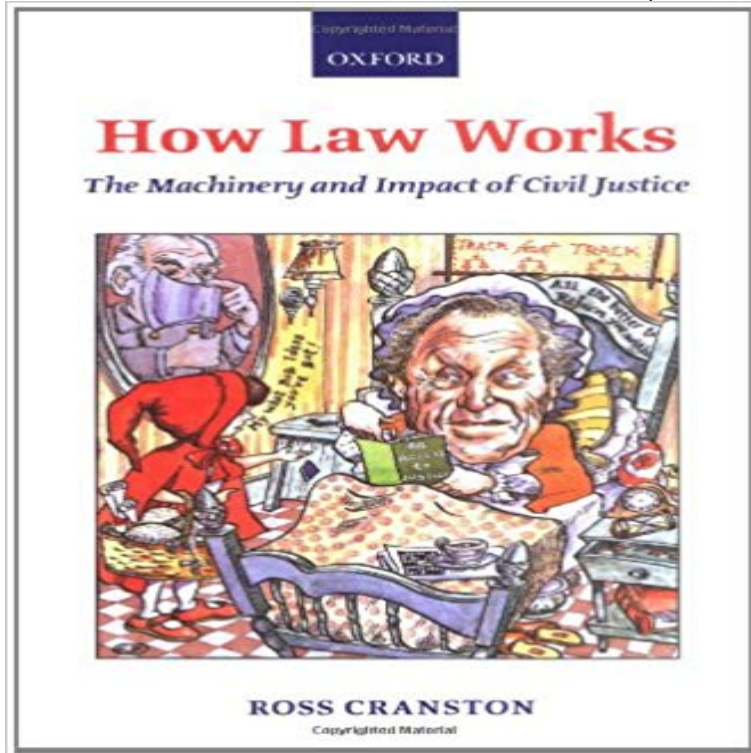


How Law Works: The Machinery and Impact of Civil Justice
