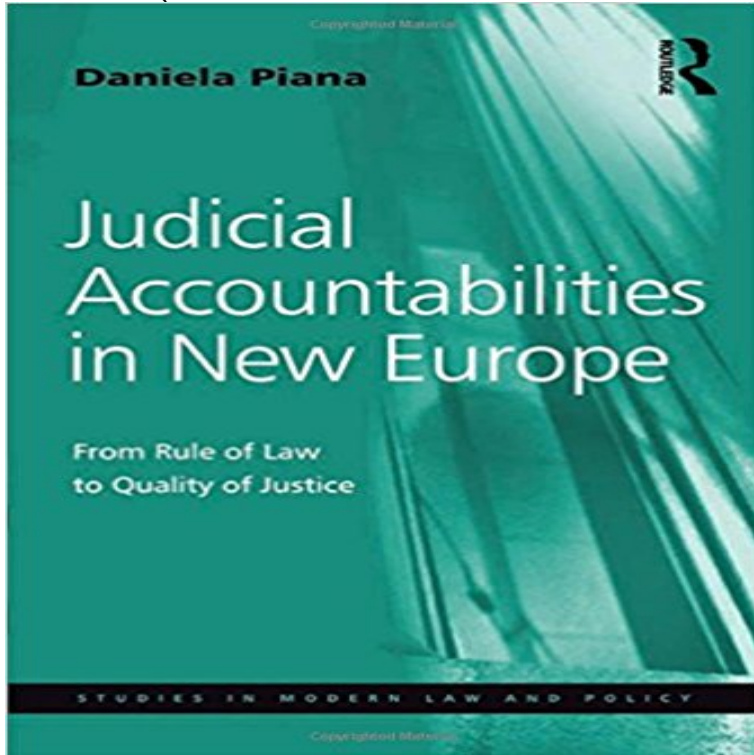


# Judicial Accountabilities in New Europe: From Rule of Law to Quality of Justice (Studies in Modern Law and Policy)
