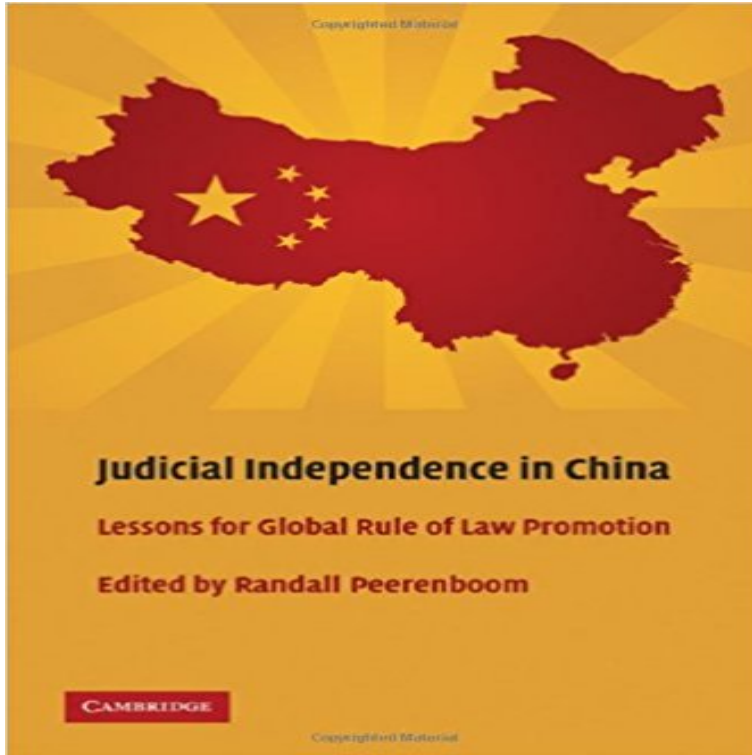


Judicial Independence in China: Lessons for Global Rule of Law Promotion
