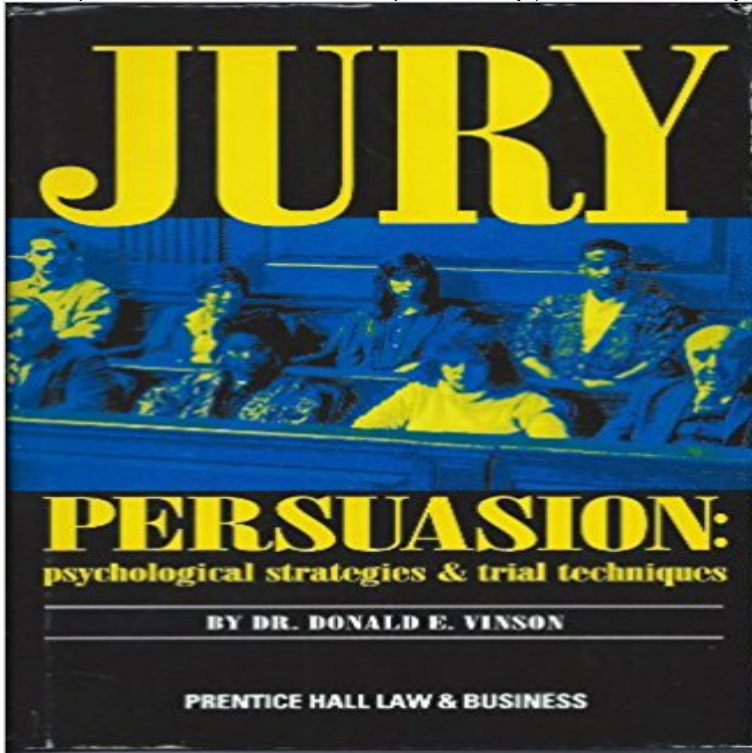


## Jury Persuasion: Psychological Strategies & Trial Techniques
