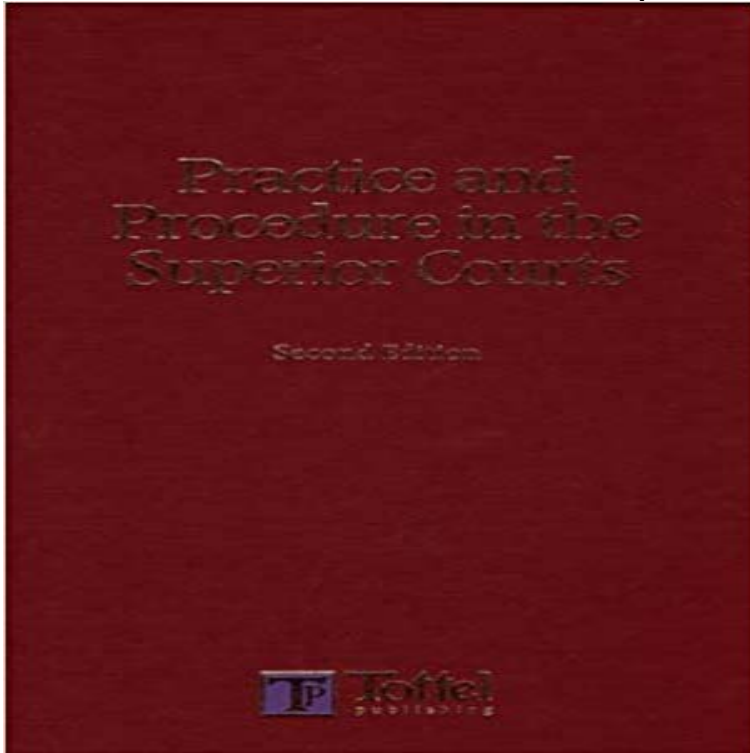


## Practice and Procedure in the Superior Courts: Second Edition
