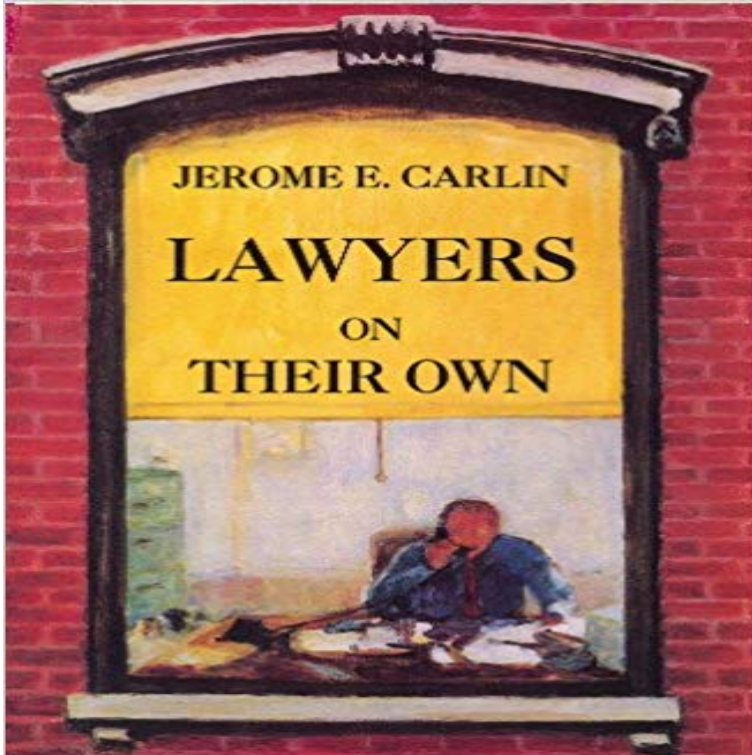


Lawyers on Their Own: The Solo Practitioner in an Urban Setting (Classics of Law & Society)
