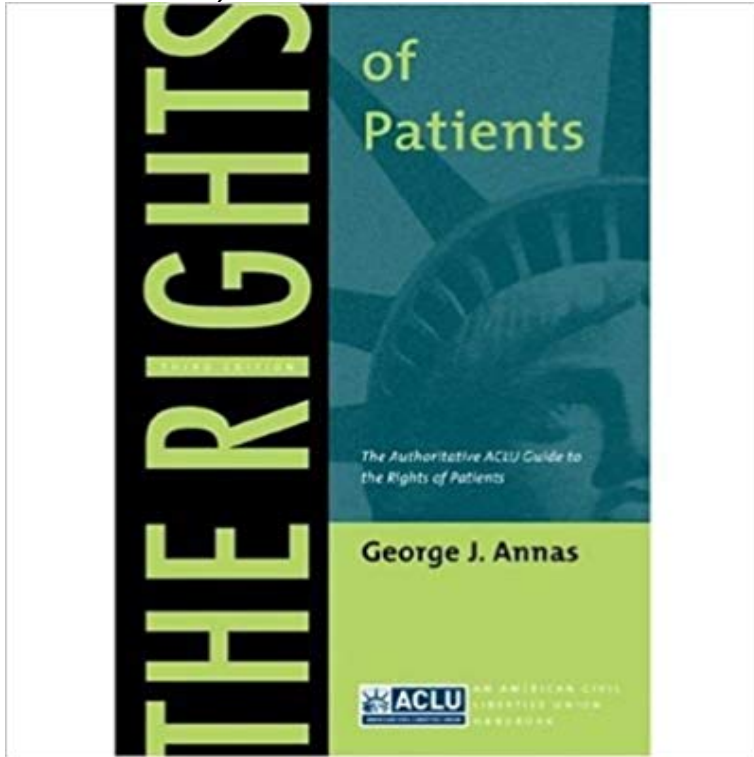


# The Rights of Patients: The Basic ACLU Guide to Patient Rights (ACLU Handbook)
