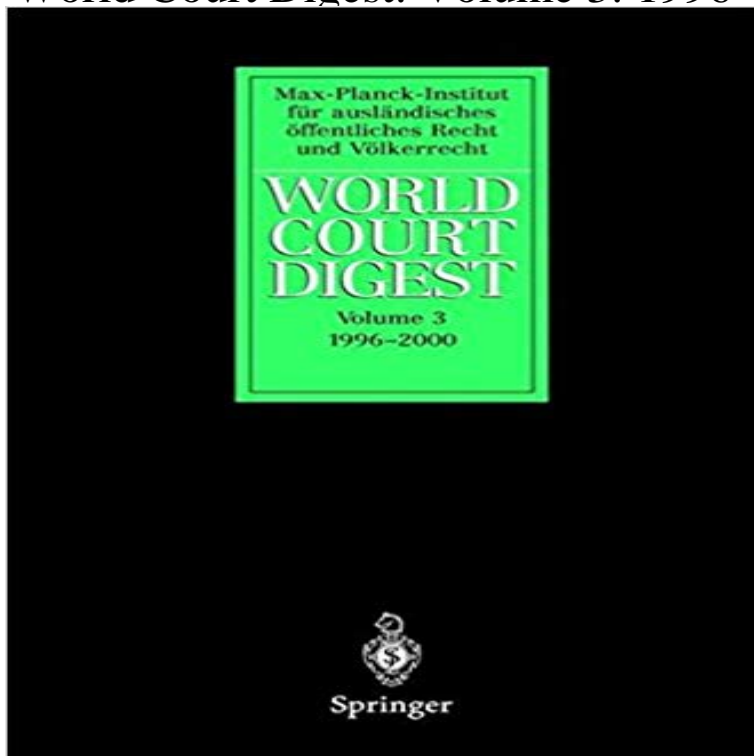


## World Court Digest: Volume 3: 1996 - 2000
