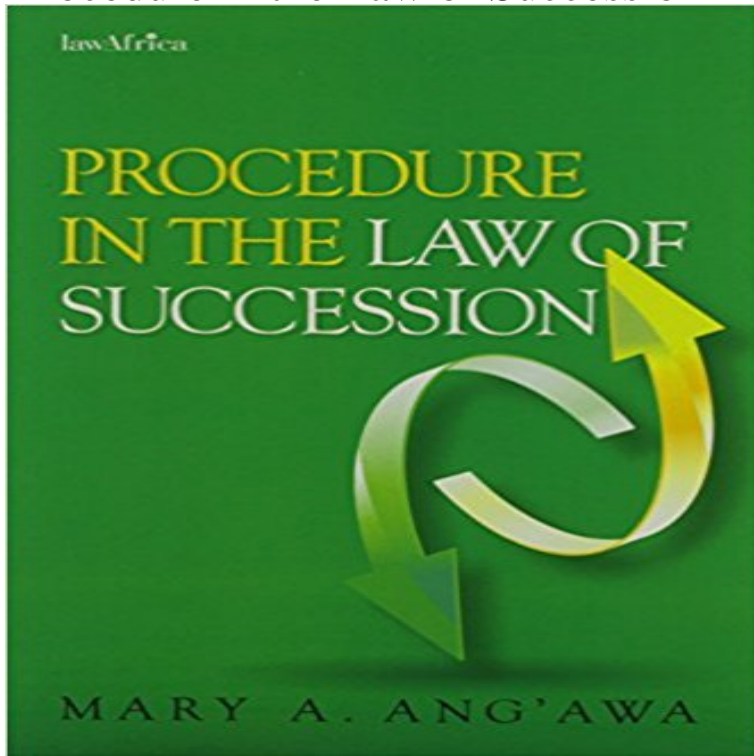


## Procedure in the Law of Succession in Kenya
