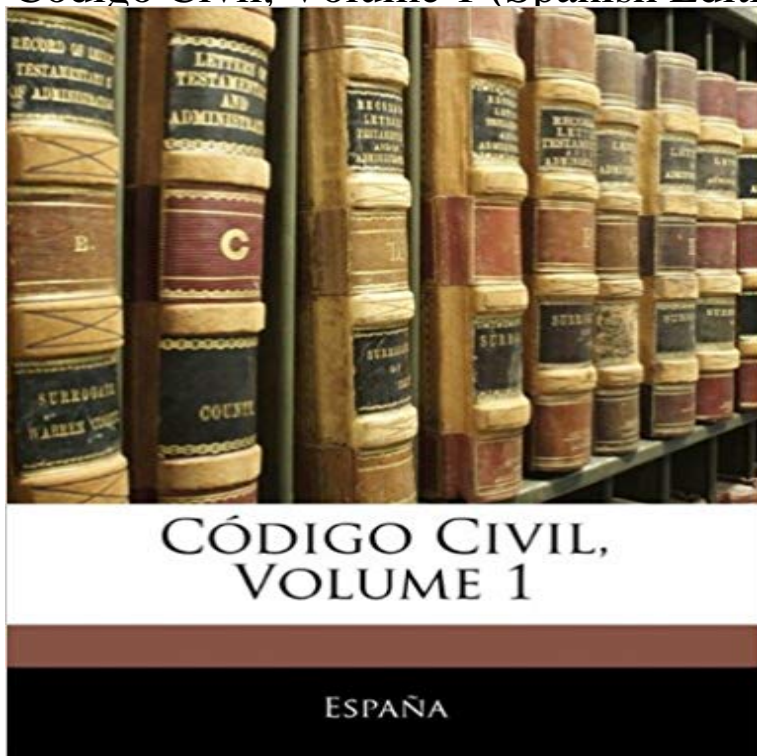


## Codigo Civil, Volume 1 (Spanish Edition)
