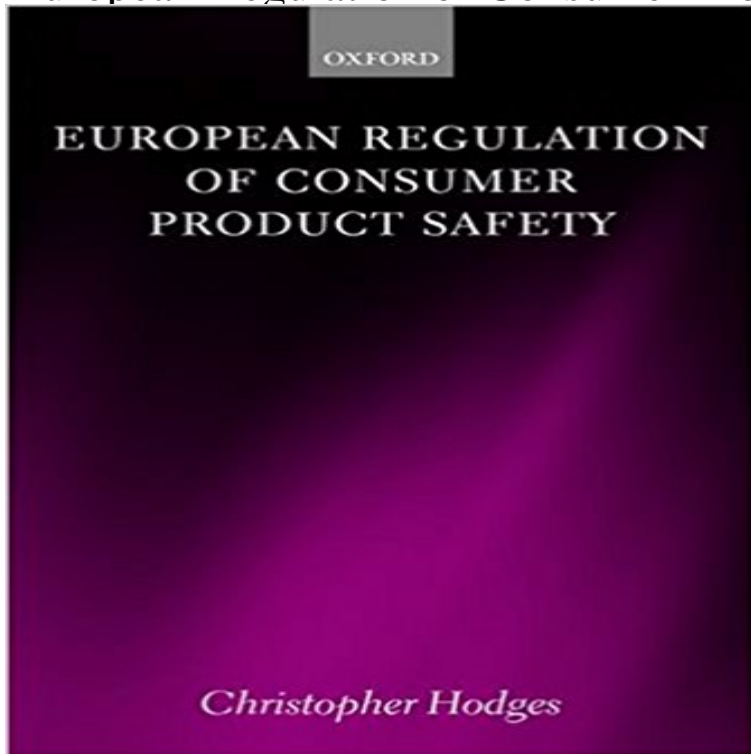


# European Regulation of Consumer Product Safety
